# After tragically losing son, couple seeks to adopt again

Austin and Valerie DeArmond had their prayers answered in 2018 when they adopted their daughter, Addison. Four years later the couple, who believed they were unable to have children on their own, was blessed again when Valerie became pregnant with their son, Gabriel.

But tragedy soon struck.

Gabriel, who was born in January 2022, passed away in January of 2023 due to complications related to a complex febrile seizure.

"We had a wonderful year with him, 366 days to be exact," Austin said. "It is the greatest tragedy of our lives but we constantly remind ourselves what a rich blessing it was to have that year with him. There's deep pain but also immense gratitude. We know Gabriel did not have to be. Yet, he was. We will forever be grateful for the time with our precious son and believe the longest chapter is ahead in Heaven with him."

After Gabriel's death, Austin and Valerie are looking to adopt once again. The couple says their daughter, now 6-year-old Addison, has been one of life's sweetest and richest blessings. And she was a great big sister to Gabriel. They'd love to give her another sibling.

## **Animal Shelter makes it easier** for volunteers to receive training, help pets get adopted

The expansion of the St. Charles Parish Animal Shelter volunteer training program has made it much easier for residents to visit the shelter to spend time with the animals.

Volunteer training sessions used to be held once a week, but now those interested in volunteering can visit the shelter during operating hours five days a week to learn about the shelter's disease prevention protocols and rules, take a short quiz and start volunteering.

"The St. Charles Parish Animal Shelter revamped its volunteer training program about two months ago. The orientation is now much smaller than the large groups that previously attended the training when we offered just one session per week," Dr. Jena Troxler, supervisor of the animal shelter, said. "This schedule helps to make it more accessible and in smaller groups, giving our volunteers a more personalized experience."

The orientation takes about 20 minutes to complete, in addition to a 10-minute personal tour of the shelter. After that, volunteers are set to go behind the scenes.

Once residents have been trained, they can interact with the animals by socializing kittens, offering enrichment, giving baths, walking dogs, and helping get the pets ready for adoption. The shelter also offers a Rescue Run



Club on Thursday mornings at 6 a.m., where volunteers can take dogs on walks, jogs, or runs in the area around the shelter, giving them exercise and working on their leash manners.

Troxler added that there is no age limit to be a volunteer at the shelter.

"We value the fact that children take a strong interest in learning empathy and caring for pets," she said. "They are part of orientation with a parent and volunteer with a

## **Hahnville senior signs** with virtual reality gaming company

Ian Fischer smiled broadly as he spoke about the unique opportunity before him.

"It's awesome - I'm enjoying every minute of it and I'm excited about everything that's to come," Fischer said.

Last week, St. Charles Parish Public Schools held a Career and Technical Education Letter of Intent Signing Ceremony that saw 10 of the school district's top students accept apprenticeship-type positions with various companies.

Fischer, a senior at Hahnville High School, signed with Striker VR, a virtual reality gaming company under the umbrella of HapTech Inc., a company founded by Hahnville High School alum Kyle Monti. HapTech is centered around haptics, the technology that gives real world sensations to virtual reality experiences. HapTech innovates military training weapons. Its training weapons are unique because they use magnets to create hard-hitting recoil that's more realistic, less expensive and easier to maintain than the traditional

training weapon technology that was developed in the 1970s.

Fischer has been working on the Striker side of things for the past several weeks. The signing day made official what he had been offered a few days earlier a paid two-month internship position with the company, where decision-makers saw potential worth exploring in the student from the work he had done with the company already in a learning capacity.

'When they told me 'we want you to stay, it was really a 'let's go!' type of moment," Fischer said. "It was a goal I had - not necessarily expected though. I wanted to go there to learn about the industry and see if it is something I'd like to continue to pursue. I'm very excited to be able to continue there."

Fischer, a top member of Hahnville's robotics team, said his interest in computers and software spurred him to explore an opportunity he came across a few years ago.





Keith Dacus and the St. Charles Parish Hospital team for bringing this to our residents and en-

suring they have safe, summer fun."

Throughout May, the Ormond Spray Park will be open on weekends only, Saturday and Sunday, from 1 p.m. - 6

After Memorial Day, on May 28, the Ormond Spray Park will open for its traditional summer operating hours, Tuesday through Sunday from 1 p.m. -6 p.m.

Beginning Aug. 26, the park will revert to weekend-only operations. The Ormond Spray Park will close for the season on Sept. 30.



Throughout the season, the Ormond Spray Park will be closed on Mondays for maintenance.

"We believe God has called us to move forward and adopt again, stewarding Gabriel's legacy along the way," Austin said. "I don't believe my wife is done mothering a baby. She really came alive seeing and watching our two children play and love on each other. I remember her saying as she watched our two chil-

dren play together, 'This is it. This is the best thing in the world.' I want her to have that again."

The couple have always been committed to adoption because they say it's a picture of God's love, helps children and families in need and truly blesses families who cannot have children through normal means.

In 2018, the couple was quickly connected with Addison's birth mother and everything went smoothly from there.

"We became parents with Addison's arrival. There's so much joy, life, and love within our home because of Addie," Austin said. "She is spunky, bold, funny, kind-hearted, and loving. She loves cats, doing art projects, a good Disney princess movie, and playing with her friends."

This time, their adoption journey has proved a little more difficult.

"We've had potential connections that have fallen through. That, of course, is just sadly part of the process," Austin said. "We say it is a win either way-we get to adopt a precious child or a mom makes the decision to keep them, raising and loving them. We have an adoption attorney in Baton Rouge and are just praying for the Lord to provide the right opportunity in the right time in the right way."

Most adoptions utilize agencies that connect prospective parents with a child and provide legal help. However, that's a costly process. Austin said the price can range anywhere from \$20,000 to \$65,000.

"That's an excessively large number," Austin said. "We have a private adoption attorney who is committed to providing all of the services you need for an adoption without taking large amounts of agency and fa-

cility fees. We rejoice that the Lord led us to him. Adoption should not be a money-making scheme but it sadly is for so many agencies and attorneys."

Because the couple is undertaking a private search, there is more of a responsibility for them to get the word out that they are looking for a child to adopt.

"We get the word out and pray," Austin said. "Our attorney also has a Shutterfly book about our family so if a young lady comes in, she can check out our book for herself."

assistant director for parks and recreation, said. "Our team loves this event because it allows anglers of all ages and abilities to come out, fish, win a door prize and make memories at the Bonnet Carre' Spillway."

Anglers of all ages are invited to take part in the tournament, where they will try to catch bass, bream, catfish and sac-alait. There is even a miscellaneous category. The event takes place at the spillway's lower guide levee boat launch and registration for anglers 12 years and under is \$5. For those 13 and older or boat captains, the cost is \$10.

A Louisiana fishing license is required for anglers 16 and older. All Louisiana fishing regulations apply.

Registration is open through May 17 at www. scpparksandrec.com. The competition begins at safelight with weigh-in at 1 p.m.

"I have so much I want to do in life," Wear said. "I'm going to fight for my life until my last breath."

Ewing's sarcoma grows in bones or the soft tissue around bones, like cartilage and nerves. It usually affects people between the ages of 10 and 20. Regardless of where it starts, it can spread to vital organs like the lungs, heart and kidneys, and in these cases the threat is more serious. It's unclear what causes Ewing's sarcoma. It doesn't appear to be hereditary, and research suggests it's not related to environmental catalysts.

The illness affects approximately 200 children and young people each year in the United States.

When Wear was 15, he learned he had pulmonary embolisms and blood clotting. It was not until two years later that it was found the clot was caused by a tumor in his leg. On the day of his 17th birthday, he learned he had Ewing's sarcoma. He underwent intense chemotherapy and blood and platelet transfusion, and the cancer went into remission until September of 2019.

Beyond his daily fight, there are other life complications that have come as result of his struggle – the financial burden is large.

Wear's vehicle is in need of repair in order to get to and from his medical appointments. His car is also central to his income – he works as a grocery delivery driver to make ends meet.

Recently, a family friend began a GoFundMe to help raise money for Wear to repair his vehicle. That fundraiser has since been re-routed into an ongoing GoFundMe made by his sister, Victoria, last year asking for assistance for medical expenses. That page is titled "Arthur's Battle."

"In the COVID year, I'd done a bunch of credits already and learned about a program, Project SPARK in New Orleans," said Fischer. "I figured, sure, I'm already interested in these things ... I took an intro level class and really kind of fell in love with it. I started researching and learning more on my own, invested my time in it and learned what I wanted to do."

Monti said Fischer has a unique skillset that HapTech is happy to bring aboard and work with.

"You could see when he was up there, when one of the students asked why is he so interested in this, Ian's eyes lit up," Monti said. "He's been working on software interface that other companies can take and integrate into their game.

"We're so grateful for programs like this to exist to connect us with such talented individuals. We've signed the paperwork and Ian's coming on for a summer internship."

Fischer said working with the robotics team at Hahnville has helped with the transition into what he's doing now.

"Really with teamwork, mainly," Fischer said. "You learn you're not always going to be able to do it your way. And coming into this kind of industry, it's not going to be based on what you want to do – it's what is best for the company. Maybe I am working on a project but I have a chance to send out 50 blasters – I'm going to pause on what I'm doing, send those out and make money for the company that it'll be able to use for bigger projects in the future."

Sure, it's technically work – but it doesn't really feel like it to Fischer, at least not yet.

"It's just everything – I can't pinpoint one thing, I'm enjoying it all," Fischer said. "There's always a point of a job where,

OK, maybe this or that is getting tedious. But everything comes with such a sense of accomplishment and I'm so excited to show up every day for it.

"It's a different pressure level. What I was doing before was hobby-based, things need to get done here in a timely manner. But it's been great."


Fischer will continue to enjoy his internship adventure until the fall, when he will continue his academic pursuits at the University of Louisiana.

parent if they are under the age of 14. Our young volunteers are very engaged and aware of protocols for safety and disease prevention and look forward to seeing the pets as they move up to adoption healthy and ready to interact."

The youngest volunteer the shelter has had so far was under the age of two.

"Many times, families have more than one child and bring all siblings along," Troxler

Troxler said that volunteer support is important for the pets at the shelter.

"The animals get extra walks, enrichment with homemade toys and treats, plus interaction with a variety of people so they are well adapted to people beyond our shelter staff," she said. "Our volunteers also learn the personalities of the pets and help us promote them for adoption. We are open two Saturdays per month, and we even welcome oriented volunteers to check a dog out for an outing - some establishments and parks allow pets, and that's a great way to get them seen in the community."

The shelter is open Monday-Friday from 8:30 a.m. until 4 p.m., in addition to two Saturdays a month.



DHS track star captures crown, two other top 3 finishes at state meet.

Destrehan's Marley Richard capped a sensational track and field season with the Class 5A state championship crown in the girls' triple jump.

That performance coupled with two more top three finishes to wrap up a fantastic day at LSU's Bernie Moore Stadium at the state track and field championship meet. Richard's leap of 12.22m earned her first place, besting East St. John's Zhanell Francois who took second (11.45).

Richard also finished third in the 200 (24.22) and third in the long jump (5.54m). The DHS track star earned the state crown in the long jump last year.

For the Destrehan girls as a whole, it was a strong day at LSU as well. DHS finished seventh in the state as a team.

Bryonna Jackson took fifth in the long jump (5.31m). Ivie Mashia placed ninth in the 200 (59.10). Kiyia Jones earned fifth place in the discus (36.28m).

Hahnville's Madison Bailey finished a stellar track season as well, earning state runner-up honors in the 400 meter dash.

Bailey's time of 55.17 was good for second in the state. It followed up on regional and district championship performances by the Tigers' track star, who earned the 400 crown at both title meets.

Among Bailey's Hahnville teammates, Whitaker finished fourth in the pole vault (3.34m) and fifth in the high jump (1.57m). Jaimie Perkins took sixth in the 100 meter hurdles (15.68) and ninth in the 300 hurdles (49.43). The 4x400 relay squad of Sarah Waits, Mariah Mott, Dihlynn Mitchell and Madison Bailey took seventh (4:05.46). The 4x800 team of Avery Oertling, Carsyn Ford, Sarah Waits and Samantha Lemoine finished ninth. (10:46.89).

For the Destrehan boys, Tai Terrell captured third in the state in the long jump with a leap of 6.90m. He also took eighth in the triple jump (13.04). The 4x100 relay

team of Marcel Frederick, Jabari Mack, Jordan Zeringue and Damien Richard finished sixth (42.54). Phillip Wright finished eighth in the 100 (15.96). Damien Richard also took sixth in the long jump (6.80m) and seventh in the triple jump (13.37m).

For Hahnville's boys, Ryan Abadie finished seventh in the pole vault (3.66m). David Powell finished eighth in the 110 hurdles (15.19).

### **REGIONAL CHAMPIONS**


Destrehan's Marley Richard earned Class 5A-Region 3 championship honors in three different events.

Richard with a time of 24.66 in the girls 200 meter dash, edging out Hahnville's Madison Bailey (25.23). Richard was also tops in the long jump, earning the crown with a jump of 17-11.50. That beat out second place teammate Bryonna Jackson. And Richard earned the trifecta with a regional crown in the triple jump, posting a mark of 36-00.50. Kivia Jones earned the discus crown with a throw of 120-04.

Representing Destrehan's boys, Phillip Wright earned Class 5A Region 3 championships in the 100 with a time of 10.57 and the 200 with a time of 21.41. Damien Richard was the regional champion in the long jump with a leap of 22-01, just edging out teammate Tai Terrell (21-10). Richard and Terrell took second and third, respectively, in the triple jump as well.

Representing Hahnville's girls, Bailey was the champion of the 400 with a time of 55.53, beating out Ivie Mashia of Destrehan who finished second. Jaimie Perkins earned the regional championship in the 100 meter hurdles with a time of 16.19, and also earned third place in the 300 meter hurdles (46.83). The 4x400 relay squad earned their event's regional championship with a time of 4:02.54, while the 4x800 team took third.

But the feeling for me is more that the true end came two weeks earlier, as Zion Williamson departed the play-

in game between the Pelicans and the Los Angeles Lakers. We got the usual from the team - "he'll be reevaluated in two weeks," which Pelicans fans, by now, no doubt internalized as "rest up for next season." The team regrouped to beat the Sacramento Kings for the sixth time this season – when this Pels team has someone's number, they have it cold – but most of the hope of a Cinderella-like playoff run evaporated once Williamson went down for the count.

It means we're in for a crossroads of an offseason for the team. Team president David Griffin all but said that the time for waiting and seeing how this group progresses as is has passed. It's hard to disagree on that, but it's also just as difficult to visualize what comes next.

That's largely because this is a very likable team. Brandon Ingram is a star-level player who's said, time and again, that he loves it here and wants to be here – refreshing after

years of players at his level asking for trades before outright forcing them. CJ McCollum is a respected veteran. The team's young guards and wings, from Trey Murphy, to Herb Jones, to Jose Alvarado and Dyson Daniels, are beloved by the fanbase for good reason – they collectively form a group that overwhelms so many teams in the league at the defensive end.

Then there's Zion, who has drawn the fans' ire for being unavailable often thus far in his career, but is also the single most dominant force on the team when he's out there – and carries most of the Pelicans' hopes of breaking through to the championship level on his shoulders.

Most seem to think Ingram will be the odd man out. He's due a contract extension by next offseason, and between the contracts of Williamson, McCollum, Ingram and Trey Murphy who will also be up for extension soon, it is probably unworkable to keep all on a team that's shown flashes at times, but only flashes.

Is there more room for growth with this roster as is? Perhaps.

But this postseason is also working as a major point against the "run it back" notion.

A year ago, the Pelicans, Oklahoma City Thunder and the Minnesota Timberwolves were all play-in teams. This season, the Thunder and Wolves zoomed up the Western Conference standings, each making massive leaps. The Thunder are the first seed in the West and as of this writing Tuesday night, had not lost a playoff game yet – including their 4-0 sweep of the Pelicans.

The Wolves, meanwhile, were also unbeaten from their 3 seed – and have done the unthinkable, taking two games at defending champion Denver, a team that very rarely loses at home at all, less so in the playoffs. Game two at Denver saw the Wolves make the Nuggets look like they belonged in a lower league altogether.

The Pelicans aren't in the ballpark of these two teams. Williamson would have made the Pels/Thunder series far more interesting, but he was also healthy for most of the season; there was nonetheless a sizeable gap in wins and seeding. And the way the Thunder all but erased Ingram and McCollum was concerning to say the least.

The good news is that whatever Griffin decides to do, he likely has the ammo to get it done. The Pelicans have a wealth of draft picks in the coming years. The roster is deep and talented.

I don't foresee him sitting on his hands. These playoffs have seemingly been all about a changing of the guard. It was thought the Pelicans would be part of that ascending number. They still can be – it just turns out there's still some work to do.






